COVENANT NOT TO SUE AND INDEMNITY AGREEMENT

1. I, _____, am about to voluntarily participate in various activities, including flying activities, of the Pride and Honor Flight, a non-profit organization, as a Guardian, or passenger. In consideration of this organization permitting me to participate in these activities, I, for myself, my heirs, administrators, executors and assigns, hereby covenant and agree that I will never institute, prosecute, or in any way aid in the institution or prosecution of, any demand, claim or suit against the organization known as Pride and Honor Flight for any destruction, loss, damage or injury (including death) to my person or property which may occur from any cause whatsoever as a result of my participation in the activities of the Pride and Honor Flight organization.

If I, my heirs, administrators, executors, or assigns should demand, claim, sue or aid in any way in such a demand, claim or suit, I agree, for myself, my heirs, administrators, executors, and assigns to indemnify the Pride and Honor Flight organization for all damages, expenses, and costs it may incur as a result thereof.

I know, understand, and agree that I am freely assuming the risk of my personal injury, death or property damage, loss or destruction that may result while participating in Pride and Honor Flight activities, including such injuries, death, damage, loss or destruction as may be caused by the negligence of the Pride and Honor Flight organization, and that medical insurance is the responsibility of the Guardian and I understand Pride and Honor Flight does NOT provide medical care.

I also understand and agree that I may be held liable for any damages or loss to the Pride and Honor Flight organization which is caused by my gross negligence, willful misconduct, dishonesty, or fraud and for limited damages or loss to the Honor Flight organization which is caused by my simple negligence.

I further understand that the term Honor Flight organization includes the non-profit organization known as Pride and Honor Flight, any officer, agent and/or employee thereof, or any Honor Flight member, participant, user or flight or ground instructor, acting officially or otherwise.

As photographic and video equipment are frequently used to memorialize and document Pride and Honor Flight trips and events, I hereby release the photographer and Pride and Honor Flight from all claims and liability relating to any photos/videos used solely for the purposes of Pride and Honor Flight promotional material and publications, and waive any rights or compensation or ownership thereto.
